## **Extended Sites (UAF):**

#### Ben Kuntz:

I have been a full-time English professor at the Kuskokwim Campus of UAF since 2007 and spent 7 years representing KuC on the Executive Board of the UAFT union before and during the merger with United Academics. A Kuskokwim Campus faculty member who was on the UNAC Representative Assembly was non-renewed last year, and I think it is important to maintain representation of the extended campuses. Extended campus faculty members are atypical in lots of ways: most of us have bipartite contracts, for instance, and we negotiate our workloads with campus directors. As someone familiar with that system and other rural realities, I believe I could help the RA protect the rights of all the faculty members represented by UNAC.

### UAA:

### Tara Palmer (formerly Smith):

I have been a faculty member at UAA since fall 2001. I served as UAFT grievance co-chair in AY04 with Steve Johnson and I am a member of the current UNAC Negotiations Team. I have been involved in a great deal of shared governance work including chair of the first two years of the Academic Assessment Committee, University-wide Faculty Evaluation Committee, president of Faculty Senate, and chair of Faculty Alliance. I am committed to the mission of higher education, academic freedom, and collective bargaining. Last spring, I was appalled at the actions of administration in the elimination of academic programs and faculty, and I would like to be able to do more than offer my sympathies to my colleagues who are being fired. I would like to contribute to the work of the UNAC Representative Assembly.

#### **Dorn Van Dommelen:**

Bio: "Dorn Van Dommelen is a Professor of Geography at the University of Alaska Anchorage in his 27th year of service. He led the creation of the successful Environment and Society B.S. program which was recently deleted. He received his B.S. in Geography at Penn State, M.A. at the University of Kentucky, and Ph.D. at the University of Toronto."

I'm interested in being on the representative assembly to learn more about the union that represents me and to help protect the rights of faculty, which appear to be under siege by the university's administration. As a graduate student at the University of Toronto I was represented by CUPE 3902 the two times we went on strike for smaller class sizes and fair treatment. I remember then the administration referring to their position as "the university's". What was true for me then is true for me now: Administrators aren't the university, faculty and students are the university. The administration is there to serve us and support us. Administrators at UA don't understand this. They should.

### Nalinaksha Bhattacharyya:

I have twenty five years of experience as a finance faculty in three countries-India, Canada and the United States. Before coming to academics I have worked as an engineer and as a manager. My industrial and business experience has considerably influenced my teaching and research. I have two earned Ph.D.s in Finance-from the University of British Columbia and from the University of Calcutta. I also have engineering qualifications and I am a CPA, CGA. I am a member of the American Finance Association and Financial Management Association. I have been the President of the Faculty Senate at the University of Alaska Anchorage. I have also been a member of the Investment Advisory Commission of the Municipality of Anchorage.

Before joining academia I have had extensive managerial and administrative experience in both public sector and private sector. I was the Works Manager of Mancheswar Carriage Works of Indian Railways. I managed a workforce of around 200 people and I was responsible for the regular working and planning for output for the workshop. Subsequently I was a manager with a finance company. I worked as the Executive Assistant to the Managin Director and in the capacity I worked on strategic planning, compliance and implementation issues for the organization.

I am an active researcher and teacher. I have collaborated with researchers from universities in Canada, US and France. I am also interested in multi disciplinary research because I believe that all human knowledge are connected and there are interesting questions which require that researchers from different fields combine their strengths. I have therefore

collaborated with researchers from other functional disciplines like accounting, marketing and operations research. My research reflects my eclectic set of interests.

I have taught different types of finance courses to different audiences in three countries. As a teacher I planned my teaching, prepared for my courses, was available to my students, treated my students with respect and kindled the love of learning in them.

I am standing to be a member of the Representative Assembly of the UNAC. I believe that a strong union leads to a more equitable and fair working atmosphere. A strong union is also needed to protect our Academic Freedom without which a University just becomes a shell. On an earlier occasion too I have been a member of the RA. I'll be happy to answer any questions you might have.

### UAF:

### Stephen Brown:

I am a Professor of Agricultural Extension and serve as the District Agriculture Agent for the Mat-Su/Copper River areas of Alaska. I think I would bring to the UNAC Representative Assembly the perspective of non-Fairbanks based faculty and their needs. I would like to serve on the Representative Assembly as a way to give back to the organization.

### Robin Shoaps:

I am writing to formally declare my interest in serving as a member of the RA. I have been a UNAC member since arriving at UAF as a term faculty member in Fall 2012. I joined the tenure track the following year. I am motivated to volunteer because I feel a debt of gratitude for the conditions of employment that I enjoy: I appreciate the transparency of our CBA (and even the fact that we have a CBA, having worked in institutions without union representation) and have benefited directly from the terms offered to term faculty members. The salary and benefits (including a moving allowance) were far more generous than one year assistant professor visiting positions in my highly competitive field generally are.

I come from a union family: my father and grandfather were both active in their respective unions (Michigan teachers' and Michigan dairy farmers') and before retiring, my dad was a negotiator. I learned the word "scab" as a kid (I also grew up near a GM plant in the 80s, so...). I see getting more involved in UNAC as a complement to my work as a member of the Committee on the Status of Women, which is in the process of advocating with Statewide for better parental leave policies.

As you can see from my signature line, I am recently tenured Associate Professor of Anthropology and Linguistics. In addition to my elected position on COSW, I have served as Program Coordinator for Women's, Gender and Sexuality Studies, as an alternate on Faculty Senate, as the Social Sciences representative on GERC and as a member of GAAC.

Dear Seriator/Representative A,

On June  $5^{th}$ , 2020, the University of Alaska Board of Regents (BOR) passed a resolution with a 7-4 vote, proposing an analysis of the processes associated with merging the University of Alaska Southeast (UAS) into the University of Alaska Fairbanks (UAF).

United Academics, which represents more than 1,000 full time faculty members across the three individually accredited universities serving 24,000 students, firmly opposes any actions by the Board of Regents that consider major structural changes to the UA System, such as potentially merging UAS with UAF, without 1) a clear cost-benefit analysis, 2) adequate input from stakeholders, and 3) satisfactorily addressing excessive administrative costs at the University of Alaska. According to an NCHEMS report commissioned by the UA Board of Regents, the University of Alaska System spends 170% of the average for administrative expenditures per student full-time-equivalent (FTE) at public university systems in the United States. A reduction in administrative spending at UA to 130% of the average would go a long way to accommodate future state funding declines (Compact between the Governor and the BOR) and the costs and lost revenues from the COVID-19 pandemic.

Any decision by the Board of Regents and the Administration to reorganize or relocate academic programs should be preceded by a detailed cost benefit analysis. This should include a publicly available accounting of both the fiscal and academic benefits and costs, be vetted by the affected Faculty Senates, and allow an adequate public comment period before a final decision is made or implemented.

We also want to make legislators aware of some of the programs and services that UAS provides to 70,000 Alaskans living in Southeast Alaska, which could potentially be jeopardized in any merger.

As a faculty union committed to the ideals of higher education and our collective bargaining agreement, we will continue to monitor this situation to uphold our mutual contract with the university in service of our members; however, we will firmly oppose any plan that proposes to cut healthy academic programs in order to maintain a costly administrative system. We hope that you will join us in monitoring this situation.

Thank you to Representative Assembly members John Radzilowski, Max Kullberg, and Nelta Edwards for their extensive work on this and working with everyone to create these now broadly supported letters. These members with the Legislative Affairs Committee members agreed to distribute the letter to individual Legislators on behalf of the Representative Assembly. This was identified as a great opportunity for rallying the United Academics membership behind these letters as an organizing tool. The Representative Assembly members mentioned above agreed to survey the membership about what they would be willing to do to support the intent of the letters. They will provide an update to the Representative Assembly on these efforts at the next meeting.

Motion to approve the letter to the Board of Regents – Motions to amend – Approved.

Motion to approve the amended letter to the Board of Regents – *Approved*.

Dear University of Alaska Board of Regents Members,

United Academics wholeheartedly supports the Board of Regents in its effort to reduce costs given the compact with the governor and the COVID-19 pandemic. However, we firmly oppose further cuts to healthy and essential academic programs without further reductions in administrative costs. According to an NCHEMS report commissioned by the UA Board of Regents, the University of Alaska System spends 170% of the average for administrative expenditures per student full-time-equivalent (FTE) at public university systems in the United States. We do not support further erosion of the academic missions in teaching, research and public service of the three universities in favor of maintaining costly administrative structures, the maintenance of which robs Alaskans of educational opportunities.

We commend the three Faculty Senates in their support of UAS, and the Faculty Alliance for their efforts to represent the collective voice of faculty to the BOR on this issue. In the spirit of effective shared governance (United Academics AAUP/AFT #4996 - Constitution, Article 2.5; Collective Bargaining Agreement, Article 2), we respectfully request that, Chair Buretta ask Faculty Alliance to coordinate the election of faculty members with at least one faculty member from each of the universities to join the working committee as stipulated by BOR's June 5, 2020, resolution to examine a proposed merger of UAS to UAF.

Pursuant to shared governance best practices, these three faculty would be selected by their respective faculty governing bodies. The insight and experience of these faculty on the working group will only serve to strengthen the thoroughness of its analysis and more importantly, demonstrate the Board's adherence to the standards of shared governance that are required not

only by the Northwest Commission on Colleges and Universities (NWCCU), but also the American Association of University Professors (AAUP) and the American Federation of Teachers (AFT).

We respectfully ask that the working group produce a publicly accessible cost-benefit analysis and that faculty and students from any impacted programs have an opportunity to weigh in before any final decisions are made. We are skeptical that UAS is much of a cost-driver given that it is only 7.6 percent of the entire budget and expect the working group to demonstrate areas of cost savings. United Academics will oppose structural changes that unnecessarily diminish opportunities for students in Alaska.

Furthermore, we affirm the unique nature of Southeast Alaska as a region in the state with its own strengths and challenges. We ask that the committee and BOR maximize the input from the stakeholders in the region such as their desire and demand to maintain an independent, separately accredited university that provides them with opportunities for in-person and online classes and degree programs. We also call on the working group to consider the ways in which UAS meets the general and unique needs of the 70,000 Alaskans living in the panhandle for a place-based, affordable, quality education and offers the following services and programs that are particularly important to their communities and could be negatively impacted by the proposed merger. It is a fact that UAS has nourished close ties with local school districts, multiple Alaska Native communities and corporations, hospitals, industry, business, state, city, and borough governments, museums, and arts organizations that add to the region's vitality. As noted in NWCCU's outreach to the board last fall, listening to stakeholders is a key aspect of effective university operations. Decisions made should reflect the incorporation of their input.

Whether or not the working group finds that the merger of UAS into UAF is a good idea, the BOR should understand that UNAC will continue to monitor working conditions of our members pursuant to our contract with the university. We will be paying close attention to any changes in employment status of our membership, and we expect to be notified before any member's position, locus of employment, or status is affected by this or any other proposal so that we may effectively fulfill our role in negotiating how these changes are handled and to ensure that member rights are upheld. Of particular import will be matters such as time towards promotion, tenure status, accrued benefits, changes to promotion and tenure requirements, and other working conditions. We will hold the Board of Regents and the Administration to the highest standards of shared governance. We are encouraged that Chair Buretta recently stated in the Frontiersman that "One of the reasons the board felt so strongly about Pat as interim president was because of her demonstrated commitment to a spirit of partnership with university leadership and the principles of shared governance."

President Abel Bult-Ito will email the signed letter on United Academics letterhead to the Board of Regents and cc the Representative Assembly.
