To United Academics Bargaining Unit Members:

Today the University of Alaska Administration declared impasse during mediation for our Collective Bargaining Agreement, as you may be aware from President Pitney's email this evening. The University Administration made this unilateral declaration, which is the result of its refusal in mediation to make any movement on its most recent best and final offer (dated April 25, 2022 and available on our website at unitedacademics.net.) UNAC made significant concessions in mediation and it is our position that progress can still be made in negotiations. We have another mediation meeting scheduled on May 18 and will update you as soon as we are able to do so. Meanwhile, you may contact your UNAC representatives and staff members if you have questions.
